

PROMOTION RULES

"EPN Cashback's Birthday"

1. General provisions:

1.2. The organizer of the promotion is Profit Entree Limited, address: 3469, British Virgin Islands, Tortola, Road Town, Waterfront Drive, Geneva Place (hereinafter referred to as the "Organizer"). Official website of the Organizer: <http://www.epn.bz>.

1.2. The name of the promotion: "ePN Cashback Birthday" (hereinafter referred to as the "Promotion")

1.3. The distribution of the prize Fund Promotions is based on the principle of random choosing winners of prizes using a hardware-software complex of the Organizer. The participation fee is not charged.

1.4. The prize fund of the Promotion is formed at the expense of the Organizer.

1.5. The promotion is held from 9 to 23 December 2017, both dates inclusive.

1.6. The Organizer reserves the right to correct and change the terms of the Campaign unilaterally, posting information about the changes on the Organizer's official website. Changes come into force from the moment of publication on the official website of the Organizer.

1.7. Participation in the Promotion means the participant's full consent to the terms of these Rules and consent to the processing of his personal data.

1.8. For any questions related to participation in the promotion and receipt of prizes, the Participant can contact by e-mail support@epn.bz.

2. Participants of the Promotion

2.1. To participate in the Promotion, an able-bodied natural person is allowed, against whom all the following requirements are fulfilled simultaneously (hereinafter referred to as the "Participant"):

- Age of the Participant: 16 years and older;

- Log in to the personal account of the ePN Partner of the Partner Program of the Organizer, after registering as a cashbacker, in the ePN Cash Service ePN of the Organizer's affiliate program posted on the Internet at: <http://www.epn.bz> and obtaining status partner.

- The transfer to the page of the Promotion, located in the ePN Cash Service ePN of the Organizer's partner program, posted on the Organizer's website;

- Adoption of these rules for the "EPN Cashback Birthday" promotion and consent to processing the data by clicking on the "Participate" button in any section (category) of the Promotion.

2.2. Any legal entities, as well as individuals who are employees and / or representatives of the Organizer, affiliates, family members of such employees and representatives, as well as employees and representatives of any other legal persons, individuals and their families who are directly related to the organization or holding of this Promotion, as well as persons who do not meet the above requirements to the Participants of the Campaign, shall not be entitled to participate in the Promotion and are not allowed to participate in the Promotion.

3. Conditions of participation in the Action and the procedure for its conduct:

3.1. Carrying out the actions provided for in clause 2.1 of these Rules, the Participant hereby unreservedly agrees and confirms its agreement with the terms of these Rules, as well as with the Organizer's right without prior notification, to unilaterally amend these Rules of the Promotion by publishing a new version of the Rules or changes in them, and also with the right of the Organizer to terminate the action of the Promotion at any time unilaterally without prior notification to the Participants of the Promotion. The Organizer has the right not to notify the Participant personally of changes to these Rules.

3.2. A Participant of the Campaign meeting the requirements specified in clause 2.1. of these Rules acquires the opportunity to participate in the Promotion. Participation in the Promotion can be made by the Participant in the categories "Holiday Cashback", "Give Gifts", "Dream Journey from ePN" Promotions.

3.3. To be able to win the prize, the Participant must perform the following actions in aggregate:

3.3.1. for participation in the category "Holiday Cashback" Promotions and opportunities to participate in the drawing of the prize (s) from the "promotional code" category:

- go to the appropriate page of the category "Holiday Cashback" of the Shares, located on the ePN's CashPack service, the Partner's program of the Organizer;
- Click on the "Get Promotion Code" button located on the corresponding page of the category "Holiday Cashback".

3.3.2. for participation in the "Give presents" category. Promotions and opportunities to participate in the drawing of the prize (s) from the "gifts" category:

- go to the appropriate page of the "Give presents" category of the Promotion, located on the ePN Cashback service of the Organizer's affiliate program;
- get a cherries, in accordance with the procedure and on the conditions specified in Section 5 of these Rules.

3.3.3 to participate in the category "Dream Journey from ePN" Promotions and opportunities to participate in the prize draw from the "travel" category:

- go to the corresponding page of the category "Journey of dreams from ePN" Shares, located on the ePN's Cashback service partner program of the Organizer;
- to receive a cherries, in accordance with the procedure and under the conditions specified in Section 5 of these Rules;
- pass the test on the page of the category "Journey of dreams from ePN" of the ePN Cashback service e-partner program of the Organizer by clicking on the "Start" button;
- on its own behalf to publish information about the category "Dream Journey from ePN" Promotion and the result of the test passed by the Participant in social networks, known as "VKontakte", posted on the Internet site at: VK.com, and "Facebook", posted on the website on the Internet at: facebook.com, using the Participant's exclusive account belonging to such Participant 1 (one) in each of the social networks (hereinafter referred to as "Repost").

4. Conditions of participation in the category "Holiday Cashback" Shares:

4.1. Each Participant in the category "Holiday Cashback" of the Promotion is provided with 1 (one) accessible prize for the "promotional code" category, each time when you press the "Get Promotion Code" button located on the corresponding page of the Event Festive Cashback category;

4.2. Specified in clause 4.1. The Rules of the Participant's action must be committed exclusively during the period of the Promotion, no more than 1 (one) time per day (24 hours), time GMT + 3, provided that the Participant commits such actions daily.

A participant who has not committed the specified in clause 4.1. of these Rules of Procedure, in the order indicated in the paragraph above, have the right to carry out such actions, before the expiration of the period of the Promotion and receive a prize (s) of the "promotional code" category that are not received by such participant from the date of commencement of the Promotion on the date of such actions;

4.3. The content, the period of receipt, the period of activation (use) and the total number of prizes in the "promotional code" category are determined by the Organizer independently and can be changed at any time, without notification of the Participants.

4.4. In the event of non-fulfillment and / or inadequate fulfillment of any of the conditions specified in this section of the Rules and / or the requirements for their determination or verification, such Participant shall not be entitled to participate in the raffle, does not acquire a prize of the "promotional code" category, and in case of its grant, The participant loses the right to use such a prize, and the generated drawing of such a prize is canceled, without any notification, explanation of the reasons, at any time.

5. Conditions of participation in the category "Give gifts" Shares:

5.1. To acquire the opportunity to participate in the draw of prizes in the category "gifts", the Participant must have at least 1 (one) cherry. One cherry received by the Participant grants such Participant the right to participate in the draw of 1 (one) prize of the category "gifts". After the draw of each 1 (one) prize of the category "gifts", the total number of cherries received by the Participant is reduced by 1 (one) piece.

5.2. Each Participant of the Promotion shall be given the opportunity to receive a certain amount of cherries, each time, if such Participant performs the following actions / compliance with the following conditions, committed or occurred only during the period of the Promotion:

5.2.1. the participant indicated reliable, complete and up-to-date information about himself in accordance with the interactive form of the Participant's questionnaire placed in the personal account of the ePN Cashback service partner program of the Organizer.

The Participant's submission of invalid and / or irrelevant data about himself, as well as the non-filling in of any of the fields of the interactive form of the Participant's questionnaire placed in the ePN's personal ePN partner account, is improper fulfillment by the Participant of the conditions for obtaining a cherry, and excludes the right of the Participant to receive them .

Participant, with his will and interest, in order to use ePN's Cashback service and other services of the Organizer's partner program, in order to participate in the Promotion, to conduct direct and / or indirect contacts with the Participant, and for the purpose of receiving from the Organizer affiliated with him persons, partners and / or financial intermediaries of information and information, including advertising and receiving messages, authorizes the Organizer and provides the latter with the opportunity and the right to collect, process, store, verify and other actions with such data, including, but not exclusively, verification of the authenticity of the information provided by the Participant to the Organizer and information about himself indicated in filling out the interactive

form of the Participant's questionnaire, by any means, methods and means, without excluding direct contacts with the Participants.

The amount of cherries to be provided to a Participant with full and proper fulfillment by the latter of the conditions of this sub-item, for the duration of the Promotion, is 3 (three) cherries. The specified amount of cherries is given to the Participant once, provided that the conditions specified in this subparagraph are properly met.

5.2.2. or, on his own behalf, the Participant carried out the publication of information about the Promotion in a social network known as "VKontakte", posted on the website on the Internet at: VK.com, using the Participant's exclusive 1 participant account in this social network (hereinafter referred to as "Repost").

The conditions for granting a cherries specified in this sub-clause shall be deemed fulfilled if the following events occurred (collectively):

- Prior to the repost, the Participant agreed to the Organizer for its execution and verification by the Organizer of the fact that the Participant carried out the Repost, including, but not exclusively, access to the data of such Participant in the relevant social network and viewing information about him and his Repost;
- The participant carried out Repost using the ePN's Cashback service partner program of the Organizer and implemented on it technical, software and graphical solutions for the implementation of Repost;
- The repost is placed before the end of the promotional period;
- The Organizer has ascertained that the Repost Participant fulfills the conditions of these Rules.

The amount of cherries given to a Participant in the full and proper fulfillment by the latter of the conditions of this sub-paragraph, for the duration of the Promotion, is 1 (one) cherry. The specified amount of wishes is given to the Participant once, provided that the conditions specified in this subparagraph are properly met.

In the event of non-fulfillment and / or inadequate fulfillment by the Participant of any of the conditions for granting a cherry and / or requirements for their determination or verification, no cherry is granted, and in case of their provision, such cherry is canceled by the Organizer without any notice, explaining the reasons, at any time. The Organizer has the right to cancel previously given cherries, as well as to cancel the prize of the Participant's prize, if the winner fails to meet any conditions for granting the cherry and / or receipt of the prize until such a Participant receives such a prize.

5.2.3. or, on its own behalf, the Participant carried out the publication of information about the Promotion in a social network known as "Facebook", posted on the Internet site at: facebook.com, using the Participant's exclusive 1 participant account in this social network (hereinafter also - Repost).

The conditions for granting a cherry specified in this sub-clause shall be deemed fulfilled if:

- Prior to the repost, the Participant agreed to the Organizer for its execution and verification by the Organizer of the fact that the Participant carried out the Repost, including, but not exclusively, access to the data of such Participant in the relevant social network and viewing information about him and his Repost;

- The participant carried out Repost using the ePN's CaspBase service partner program of the Organizer and implemented on it technical, software and graphical solutions for the implementation of Repost;
- The repost is placed before the end of the promotional period;
- The Organizer has ascertained that the Repost Participant fulfills the conditions of these Rules.

The amount of cherries given to a Participant in the full and proper fulfillment by the latter of the conditions of this sub-paragraph, for the duration of the Promotion, is 1 (one) wish. The specified amount of cherries is given to the Participant once, provided that the conditions specified in this subparagraph are properly met.

In the event of non-fulfillment and / or inadequate fulfillment by the Participant of any of the conditions for granting a cherry and / or requirements for their determination or verification, no cherry is granted, and in case of their provision, such wish is canceled by the Organizer without any notice, explaining the reasons, at any time. The Organizer has the right to cancel previously given cherries, as well as to cancel the prize of the Participant's prize, if the winner fails to meet any conditions for granting the cherry and / or receipt of the prize until such a Participant receives such a prize.

5.2.4. or, during the period of the Action, the Participant carried out the order (s) of the goods (works, services) using the ePN's Cashback service partner program and such Participant received a remuneration (hereinafter referred to as the Cashback) from the Organizer for using the ePN cashback service affiliate program, in accordance with the procedure and terms of calculation, accrual and receipt of such remuneration by the Participant, stipulated by the rules of using the Cashback service of ePN affiliate program by Organizer.

The conditions for granting a cherries specified in this sub-clause shall be deemed fulfilled if the following events occurred (collectively):

The orders made by the Participant, during the validity period of the Promotion, are valid, completed, paid for by them, confirmed by the seller of the goods (works, services) as valid and executed by the latter;

The software-hardware complex of the Cashback service ePN of the Organizer's partner program received information from the seller of goods (works, services) indicated in the paragraph above;

With respect to such Participant's orders, the ePN's Cashback service of the Organizer's affiliate program reflects the status of "confirmed";

During the validity period of the Promotion, the Organizer has calculated, accrued to the Participant Cashback and in relation to such Cashback in the Cashback service ePN of the Organizer's partner program, the status "available" is reflected.

The total amount of cherries of each Participant received by the latter in accordance with this sub-clause is unlimited and is determined in the following order: total amount of cherries = the total amount of the Participant's Cashback corresponding to the terms of this subparagraph of Rules and received during the Promotion / 1 (one) U.S. dollar. At the same time, when calculating the number of cherries, the calculation is carried out to an integer value, the value is not rounded off. In the event that a Cashback Participant receives a currency other than US dollars, the amount of cherry is calculated after converting the amount of such Cashback into US dollars, based on the following exchange rate:

1 US dollar = 60 (sixty) rubles of the Russian Federation,

1 US dollar = 0.9 (zero point nine) cents euro;

1 US dollar = 0.8 (zero point eight) pound sterling.

When performing the conversion, the calculation is carried out to an integer value, the value is not rounded off.

In the event of non-fulfillment and / or inadequate fulfillment by the Participant of any of the conditions for granting a cherries and / or requirements for their determination or verification, cherries is not granted, and in case of their provision, such cherry is canceled by the Organizer without any notice, explaining the reasons, at any time. The Organizer has the right to cancel previously given cherries, as well as to cancel the prize of the Participant's prize, if the winner fails to meet any conditions for granting the cherry and / or receipt of the prize until such a Participant receives such a prize.

5.2.5. A new partner is involved in the Promotion, in the Cashback ePN service of the Organizer's partner program.

The condition for granting a cherry specified in this sub-clause is considered fulfilled if the following events occurred (collectively):

- The participant clicked on the button "invite", located on the corresponding page of the category of the campaign "Give presents";
- The participant generated a hypertext link to go to the ePN registration page of the Partner Program of the Organizer, containing the corresponding identifier of such Participant, using the ePN software package of the Partner Program of the Organizer, used to attract a new partner;
- In the ePN Cashback service of the Partner Program of the Organizer, the Participant is involved in the person who made the transition through the hypertext link generated by such Participant using the ePN software package of the Partner Program of the Organizer to the Partner Registration page of the ePN Partner Program of the Organizer's Partner Program, rules for the use of the ePN Cashback service by the Organizer's partner program, which previously did not register with the specified Organizer service (hereinafter referred to as the "Organizer"). - New partner);
- A new partner has been registered as a partner of the ePN Cashback-service partner program of the Organizer, in accordance with the procedure and conditions for registration and use of such an Organizer's service;
- The new partner is given the status of a partner in the ePN Cashback service of the Organizer's partner program and the latter has not lost this status during the entire period of the Promotion.

The amount of cherries given to a Participant in the full and proper fulfillment by the latter of the conditions of this sub-paragraph, for the duration of the Promotion, is 1 (one) cherry. The specified amount of cherries is given to the Participant once, provided that the conditions specified in this subparagraph are properly met.

In the event of non-fulfillment and / or inadequate fulfillment by the Participant of any of the conditions for granting a cherry and / or requirements for their determination or verification, no cherry is not granted, and in case of their provision, such cherry is canceled by the Organizer without any notice, explaining the reasons, at any time. The Organizer has the right to cancel previously given cherries, as well as to cancel the prize of the Participant's prize, if the winner fails

to meet any conditions for granting the wish and / or receipt of the prize until such a Participant receives such a prize.

6. Conditions of participation in the category "Journey of dreams from ePN" Promotions:

6.1. To acquire the opportunity to participate in the prize draw of the "travel" category, a Participant must have at least 1 (one) cherry. The order and condition of obtaining a cherry corresponds to the procedure and conditions specified in Section 5 of this Promotion.

6.2. To each Participant of the Promotion, corresponding to the conditions of clause 6.1. of these Rules of the Promotion, the opportunity to take part in the drawing of the prize "travel" category, provided that such Participant fulfills the following actions / compliance with the following conditions, made or occurred only during the period of the Action (in aggregate):

6.2.1. The participant passed the test, placed on the page of the category "Journey of dreams from ePN" Promotions of the ePN Cashback service of the Partner's program of the Organizer by clicking on the "Start" button. The specified test is considered to be passed by the Participant, provided that the latter has answered the entire test question, without any exceptions;

6.2.2. The participant on his behalf carried out the publication of information on the category "Dream Journey from ePN" Promotion and the result of the test passed by the Participant in social networks, known as "VKontakte", posted on the Internet site at VK.com, and "Facebook", posted on the website on the Internet at: facebook.com, using the Participant's exclusive account belonging to such Participant 1 (one) in each of the social networks (hereinafter referred to as "Repost").

A participant is considered to have carried out a repost, provided that:

- Before the repost, the Participant agreed to the Organizer for its execution and verification by the Organizer of the fact that the Participant carried out the Repost, including, but not exclusively, access to the data of such Participant in the relevant social network, viewing information about him and the Repost committed by him;
- The participant carried out Repost using the ePN's Cashback service partner program of the Organizer and implemented on it technical, software and graphical solutions for the implementation of Repost;
- The repost is placed before the end of the campaign period;
- The Organizer has ascertained that the Repost Participant fulfills the conditions of these Rules.

In the event of non-fulfillment and / or inadequate fulfillment by the Participant of any of the conditions and / or requirements provided for in this section of the Promotion Rules, the Participant does not acquire the right to participate in the prize drawing of the "travel" category, and in the event of its holding and / or granting such a prize, such a rally is canceled by the Organizer without any notice, explanation of the reasons, at any time. The Organizer has the right to cancel the raffle / win by the Participant of the prize category "travel", in the event that until the receipt by such Participant of the won prize, it will be established that any condition for granting the Participant the right to participate in the draw and / or receive the prize is not fulfilled by the Participant.

7. Drawing prizes and determining winners

7.1. Drawing prizes, determining the specific prize won and determining the winners, in all categories of Promotions, is carried out randomly, using a random number generator, using the Organizer's hardware and software complex.

7.2. Information on the prizes, the winners of the drawings are communicated to the winners of the Participants in any way available to the Organizer, at the discretion of the latter.

8. The prize fund and the procedure for obtaining it

8.1. The prize fund of the Promotion is formed by the Organizer and is the property of the Organizer until the prize (s) is received by the successful Participant (s).

8.2. The prize fund, the number of prizes, as well as the characteristics of the prizes of each category is determined by the Organizer independently and can be changed by the latter without any notice to the Participant, at any time. The prizes of the winning participants may differ from the images present on the Promotion website, the Organizer's website, promotional materials of the Promotion and / or in Reposts.

The prize fund consists of the following categories of prizes:

- In the category of "Holiday Cashback" Shares:
 - Promotional codes.
- By the category "Give presents" Shares:
 - Iphone X;
 - Apple Watch Series;
 - Robot vacuum cleaner;
 - Smart camera;
 - Headphones for sports;
 - Fitness tracker;
 - Car charger;
 - Quadrocopter;
 - Waterproof Bluetooth speaker;
 - Sport camera.
- Under the category "Journey of dreams from ePN" Actions:
 - Travel for two people.

8.3. The cash equivalent of the prize won by the Participant is not exercised. The prizes won by the Participants are not refundable or exchangeable.

8.4. In order to receive a prize, with the exception of the "promotional code" category, the winning bidder must provide the Organizer with up-to-date, valid and reliable information about his / her name and address, necessary for sending the prize to the latter. Within 2 (two) weeks after the end of the Promotion, the Organizer sends a request to the winning Participant for the provision of the above data and information through the use of the support channel of the ePN Cashback Service Partner Program. The submission of data and information specified in this clause by the winning Participant to the Organizer must also be carried out using the channel of technical support of the ePN Cashback Service of the Organizer's partner program. The data and information requested by the Organizer must be provided by the successful bidder within 5 days from the date of sending the request to him.

8.5. After the Organizer receives from the winning Participant the data and information required to send the last prize (with the exception of the category "promotional codes"), subject to the compliance of such Participant, the terms of these Rules and / or the requirements for participation in the prize drawing and / or the provision of prizes, and also after the latter has fulfilled all the conditions necessary to receive the prize won and receive the ePN's software and hardware complex of the Cashback service of the Organizer's partner program from the seller of goods (works, services) she needs information, in accordance with the terms of these Rules, the Organizer carries out activities to send the won prizes (with the exception of the "promotional code" prizes) to such Participants. Sending of the won prizes (with the exception of the prizes of the category "promotional codes") to the Participants is carried out by the Organizer within 90 (ninety) days from the moment of fulfillment of all conditions for sending prizes provided for by this paragraph of the Rules. Sending of the prizes won by the Participants (except for the prizes of the category "promotional codes") is carried out by the postal service, at the choice of the Organizer, at the expense of the latter.

8.5.1. With regard to prizes in the category "promotional codes", the award to the winning participant of such a prize is made after clicking on the "Get Promotion Code" button. The use of prizes in the category "promotional codes" is possible by the successful Participant provided that such Participant meets the conditions of these Rules and / or the requirements for their provision, and after the latter has fulfilled all the conditions necessary to receive the won prize and receive the ePN software package Organizer's program from the seller of goods (works, services) of all necessary information and data, in accordance with the terms of these Rules.

8.6. In case of non-occurrence of conditions for sending the prize, stipulated in item 8.5. of these Rules, including, in the event of failure by the Participant to fulfill the obligation provided for in clause 8.4. of these Rules, the sending of the prize is not carried out, and the results of the Promotion in respect of such Participants are voided completely, without any notice.

8.7. The Organizer has no obligations and / or responsibility for:

- not sending, and / or failure to provide, and / or the inability to use the prize, in case the Participant fails to fulfill any of the obligations provided by these Rules;
- not receiving a prize in the event that the Participant provided invalid, invalid, incorrect and / or irrelevant data provided for by clause 8.4 to the Organizer. these Rules;
- safety of the sent prize upon its delivery to the successful Participant, and also for the quality of the prize (s);
- for compliance by the Participant with the conditions for receiving the prize provided for in these Rules or the terms of the prize distribution provided for in the transport organization that carries out the delivery.

8.8. Unclaimed prizes, prizes, sending of which was not carried out, prizes, the lottery of which was canceled by the Organizer, as well as prizes won by the disqualified Participants, according to the present Rules, remain in the ownership of the Organizer.

9. Disqualification of the Participant and cancellation of the drawing of the prize (s).

9.1. The Organizer has the right to disqualify the Participant (cancel the participation in the Promotion (both in general and in relation to a particular category of the Promotion)) without any notification of the Participant and / or contacting any authorities, without explaining the reason, at any time case:

- inconsistency of the Participant with any of the requirements specified in these Rules of the Promotion;
- non-fulfillment and / or inadequate performance of any of the actions and / or non-occurrence of events granting the Participant the right or opportunity to participate in the prize draw;
- failure to provide the Organizer with any data and information requested by the latter and / or providing the Organizer with invalid, inappropriate, unreliable data and information;
- the commission by the Participant of any fraudulent actions, actions aimed at introducing the Organizer and / or any third persons into confusion, actions aimed at misrepresenting the information about the Participant, or the conditions and / or the result of acquiring a wish or carrying out the Promotion;

Disqualification of the Participant entails the automatic cancellation (cancellation) of all cherries and winnings, within the framework of this Promotion.

9.2. The Organizer has the right to cancel (cancel) any and / or all prizes / winnings of the Participant (s) without any notice to the Participant and / or appeal to any bodies, without explaining the reason, at any time, in the event of:

- inconsistencies in terms of obtaining and / or using prizes, including prizes in the category "promotional codes", the conditions provided for in these Rules;
- there is no reason to receive and / or participate in the prize draw, as a result of which the prize was won, even if there were no such grounds at the time of receipt of the prize and / or execution of such a prize and / or have not yet arrived and / or the Organizer and / or the Participant did not know about their absence / offensive (not offensive).

9.2. The Organizer has the right not to enter into correspondence with any disqualified Participant and / or Participant in respect of which the Organizer has made decisions on annulment (cancellation) of the drawing of the prize (s).

10. Other terms and conditions of the Promotion.

10.1. In carrying out this Promotion, as well as in connection with the issues, disputes and disagreements arising in its conduct, the legislation of the host country of the Organizer is subject to application, and the arising disputes and disagreements are subject to settlement in the authorized jurisdictional body of the country where the Organizer is located.

10.2. The Participants of the Promotion have the rights and bear the obligations established by the applicable law, as well as these Rules.

10.3. The participant (s) has the right to refuse to participate in the Promotion, at any time during the period of its holding, and also to refuse to receive the prize (s) won by them, which the Organizer should inform, using the support channel of the ePN Cashback service partner program of the Organizer's. In case of refusal to participate in the Promotion, such Participant shall not be entitled to receive cherries, prizes and participate in their raffle.

10.4. The participant is obliged to comply with the conditions of participation in the Promotion, the terms and procedure for holding the draws, recognizing the Participant as the winning Participant, the terms and procedure for obtaining the prizes of any category awarded by him, provided for by these Rules and applicable law.

10.5.
